## CONDITIONS OF ENTRY:

1. Approximately 60 works will be selected for exhibition. Large and small scale. Maximum height is 2.0 metres and maximum garden area space is 1 m x 1 m.

2. All works may not be accepted, especially if we have a great many entries. Selection is at the discretion of the Selection Panel and no correspondence will be entered into. Works must be secured and not be able to cause damage to any person or property.

3. Please submit your entry form, entry fee, images, artist statement and artist biography by Friday the 15 September 2017

4. There is a \$30 administration fee per artist and is to be paid via direct deposit:

Please ensure artist name is in the transaction description. Artworks are not eligible for selection unless payment of entry fee is made in full. Included with the entry fee of \$30 all artists must complete the entry form with an artist's statement, biography, and images.

5. Willow Tree Sculpture Garden will retain a 30% commission on all sales. Please take this into consideration when advising us of your selling price. It is a condition of entry that artist's bank account information is provided with each entry.

6. You must supply your own plinths. They must be in good condition. Some plinths available for small works please enquire.

7. Site selection for all sculptures in the exhibition is at the discretion of the Sculptures in the Garden Curator.

8. All sculptures must be for sale. No 'price on application'.

9. If you are registered for GST, your price must include GST and you are responsible for remitting the GST to the ATO.

10. All exhibitors are welcome to volunteer for the weekend roster: Saturday and Sunday 10.00 - 4.00pm for the duration of the exhibition.

11. Exhibition Set Up: Friday the 3rd & Saturday the 4th of November 2017 between 9.00am-3.00pm

12. The Artist, or representative of the artist, will be responsible for maintaining the presentation of their work throughout the exhibition, especially in the event of severe weather conditions.

13. Exhibition dismantling: pick up November 25th & 26th between 9am-3 pm or by prior arrangement. The artist must supervise and be responsible for any damage to their work and the surrounding area. All sites must be returned to their original condition after their work has been removed. Sculptures cannot be removed until after the exhibition has closed.

14. Transportation Responsibilities & Loss or Damage, Insurance Coverage. Packing and shipping charges, insurance costs, other handling expenses, and risk of loss or damage incurred in the delivery and during the exhibition time of the Artworks are the responsibility of the Artist.

15. Artists must supply an image of each work entered. The image provided by the artist will be included in the catalogue. All images submitted are to be in JPEG format (300KB minimum - 1MB maximum). The artist authorises Willow Tree Sculpture Garden to reproduce the artwork image in the exhibition catalogue, publicity, media releases and other promotions in relation to Willowtree Sculpture Gardens.
